**To purchase fireworks by an entity or individual that is not a manufacturer, distributor, or wholesaler of fireworks, one of the following conditions must be met:**

Are the fireworks to be used solely and exclusively for frightening birds from agricultural works and fish hatcheries? If yes, the purchaser shall supply a copy of the statement that has been filed with and stamped as received by the appropriate sheriff's department pursuant to the rules prescribed by the Department of Agriculture and Consumer Sales per Section 791.07 Florida Statutes. A copy of the abovementioned statement must be attached hereto.

Are the fireworks to be used as a signaling device or illumination by a railroad or other transportation agency? If yes, the purchaser must provide a copy of the business license or other government issued document evidencing that the purchaser is a legitimate railroad or transportation agency. A commercial driver's license, by itself, does not meet this requirement.

A copy of the appropriate document must be attached hereto.

Are the fireworks to be used in quarrying or for blasting or other industrial use? If yes, a copy of the quarry or mine permit or business license or other governmentally issued document showing the purchaser is operating a mine quarry or other industrial enterprise must be attached hereto.

Are the fireworks to be used in a public display? If yes, the purchaser must attach hereto a copy of the current permit from any board of county commissioners or the City of Cape Coral.
